The First Party and the Second Party mutually agree to collaborate on an up-skilling program in Internet of Things (IoT) technology in collaboration with C-DAC & several skill development programs for both faculty and students pursuing Diploma, Undergraduate and Post-Graduation courses at Sri Sivani College of Engineering, Chilakapalem (Jn), Etcherla Mandal - 532410, Srikakulam Dist, Andhra Pradesh, India.

Scope of Collaboration:

- 1) The Second Party shall provide an enrollment facility to the Bridge Course for Internet of Things Software Analyst for both faculties and students of the First Party. The training program will be conducted on the FutureSkills PRIME platform virtually (Self-Paced Learning in Online- Mode / Blended Learning 24*7 Virtual Labs), spanning a total duration of 90 hours. The Second Party shall ensure that the training registration and training enrollment process is to be conducted at a concessional price provided by the C-DAC.
- 2) The Second Party shall provide an enrollment facility for the listed skill development programs/courses for both faculties and students of the First Party on designated LMS. The training program will be conducted virtually (Self-Paced Learning in Online- Mode 24*7)

Responsibilities:

- 1) The First Party shall identify all eligible students and faculties from the college to participate in the Bridge Course for Internet of Things Software Analyst.
- 2) The First Party shall avail all the students and staff to register for the listed skill development programs/courses on designated LMS through the CSC Academy portal.
- 3) The First Party shall provide the necessary infrastructure and support for the Enrollment process.
- 4) The Second Party shall register all the eligible faculties and students, who are identified by First Party.

- 5) Upon successful completion of the program (Bridge Course for Internet of Things Software Analyst), students will receive a certificate jointly issued by C-DAC and NASSCOM & Ministry of Electronics and Information Technology, Government of India

Payment Terms and Conditions

This Memorandum of Understanding (MOU) outlines the payment terms and conditions agreed upon between Sri Sivani College of Engineering, Chilakapalem, Srikakulam and CSC Academy for the provision of services related to the registration of designated LMS. Both parties hereby acknowledge and agree to the following terms:

For "Bridge Course for Internet of Things Software Analyst" provided by C-DAC is Rs. 100 + GST per enrollment. The fee will be paid by the student directly on the FutureSkills PRIME platform while registering for the program.

The payment for the registration process of designated LMS provided by CSC Academy is Rs. 158/- per enrollment for skill development programs.

Terms and Conditions:

- 1) The collaboration period commences on 05.12.202 and it will be effective for 11 months which can be extended based on mutual consent and subject to the availability of the scheme.
- 2) Both parties shall maintain the confidentiality of any proprietary information shared during the collaboration.
- 3) Any modifications or amendments to this MoU shall be made in writing and agreed upon by both parties.
- 4) This collaboration is subject to the availability of resources and compliance with both CSC Academy and government regulations.
- 5) Either party may terminate this collaboration by providing written notice at least 30 days prior to the intended termination date.

6) The CSC Academy shall offer free registration for designated LMS to teaching Staff at the rate of one member for every 50 students enrolled at Sri Sivani College of Engineering, Srikakulam, Andhra Pradesh

- 6) Upon successful completion of the program, the Second Party shall support to facilitate the issuance of IEEE-certified certificates to the students.







WHEREAS:

3. SCOPE OF THE MoU

- 3.1 The talented students from the institutions could play a key role in technological upgradation, innovation and competitiveness of an industry. Both Parties believe that close cooperation between the two would be of major benefit to the student community to enhance their skills and knowledge.

3.2 Curriculum Design

Second Party may participate in this process as and when the First Party extends invitation for such activity. The cooperation may be sought in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.

3.3 Industrial Training & Visits

Second Party to extend the necessary support to deliver expert lectures to the students of the First Party on the technology trends and in-house requirements and vice-versa.

3.7 Faculty Development Programs

Second Party to train the Faculties of First Party for imparting training as per the requirement in concerned sector/specialization, if available and vice-versa.

3.8 Training and Placement of Students

Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/jobs; and will facilitate placements for the students.

3.9 Consultancies, R&D and other Academic Matters

This institution was founded as a co-educational establishment and holds permanent affiliation with JNTUGV, Vizianagram. In this agreement, the term "MITS" and "SSCE" will henceforth, as context demands, be referred to individually as a "party" and collectively as the "parties."

And

Majhighariani Institute of Technology & Science (MITS) Sriram Vihar, Rayagada - 765017, Odisha, India. Represented by its Principal (hereinafter refer to as "MITS", which expression shall, unless repugnant to the context or meaning thereof, mean & include its successors & assigns) being the part of first party.

Whereas:

- a. **SSCE** is engaged in service of Engineering & Technical Education with college name referred as SRI SIVANI COLLEGE OF ENGINEERING in the Srikakulam District, Andhra Pradesh.
- b. **MITS** is engaged in service of Engineering & Technical Education with college name referred as Majhighariani Institute of Technology & Science.

I. OBJECTIVES OF MOU:

1. To promote & enhance academic interest between MITS and SSCE
2. To provide advice for implementation of quality of education between MITS and SSCE
3. To promote research/continuing education activities between parties
4. To give guidance for quality improvement, leading to accreditation by NAAC as mentor – mentee institutes
5. Access to Information on research /education resources
6. Technical support in projects related to science and management from senior faculty or experts.

II. TECHNICAL AREAS OF COLLABORATION:

- A. A continuing quality improvement Programme to improve quality of teaching staff in both parties.
- B. Providing academic interaction by delivering special lectures at both institutes on topics of relevance to modern industry.
- C. Provide necessary helps in organizing workshops, conferences, and personality development programs at both parties for enhancement of skills in respect of faculty, staff and students.
- D. To provide training programs for Students & Staff.

III. TERMS & CONDITIONS:

1. The cost of development of infrastructure at both parties should be borne by themselves.
2. Both parties agreed to help identify and invite the faculty members & researchers from the other institutes to participate in conferences, workshops and short-term courses.
3. This MOU may be amended, removed and terminated by mutual written agreement of the parties at any time.

E. CONFIDENTIALITY:

The **MITS** and **SSCE** agreed to hold in confidence all information/data designated by the parties as being confidential which is obtained from either party or created during the performance of MOU and will not disclose the same to any third party without written consent of the other party.

F. TENURE AND TERMINATION

This MOU will take effect from the date it is signed by representatives of the two institutions. The validity of the agreement is one year from the date of agreement. Either institution may terminate the MOU by giving written notice to the other institution 30 days in advance. However, **MITS** and **SSCE** will ensure that all activities in progress are allowed to complete successfully.

This MOU is signed subject to approval of the respective academic/administrative bodies.
